Sealed Tenders are invited on behalf of State Election Commission, Bihar Patna for supply of approx 55,000 (Fifty Five Thousand) 5ml Indeible Ink/ Marker Pen having 25% total solids (Silver Nitrate Percentage) from reputed manufacturing firm, having ISI specification from any CSIR institutions/National Physical Laboratory for use ensuing Muncipal General Election, 2022.

Tender in two separate sealed covers one containing technical specification (technical bid) and another for price (financial bid) must reach the undersigned latest by **at 01.00 P.M on 30.06.2022** Envelope containing financial bid shall be oopened only when the technical bid is in accordance with the conditions laid down in the tender notice.

Delivery of the entire quantity will have to be made at the office of State Election Commission, 7, Kranti Marge (Harding Road) Patna within 20 days of the order of supply. Undue delay in supply or supply of inferior material will viewed very seriously and penal action including forfeiture of security amount and lodging of FIR against the firm may be taken.

**Technical Specification**

1. Manufacturing license, Credentials and performance Certificate must be submitted.
2. In support of the quality fo product and materials, necessary documents must be enclosed **alongwith a sample of 5 ml idndelible Ink/Marker Pen.**
3. Rs. 25,000.00 (Twenty Five Thousand) will have to deposit as earnest money in form of bank draft payable at Patna in favour of Deputy Secretary, State Election Commission, Bihar, Patna alongwith the tender.
4. No Payment will be made for items broken in transit or before delivery.
5. Income Tax Return minimum latest three financial years/ PAN certificate and GST/GST certificate should be submitted in technical bid.
6. Test report from any CSIR Institution's Lab/National Physical Laboratory in India should be submitted along with tender bid confirming the 25% total solids (Silver Nitrate Percentage)
7. The instruction lable should be in Hindi Language with SEC Logo.
8. The shelf life of Indelible Ink/Marker Pen should be clearly indicated on the label.
9. Perference will be given to the manufactures having **CSIR technology** from any CSIR institutions/ National Physical Laboratory in India.
10. Manufacturer should have the experience of national and international experience supplying the indelible ink/Marker Pen.
11. 5% of total price value deposited by the successful tenderer as security money in form of bank draft payable at Patna in favour of Deputy Secretary, State Election Commission, Bihar, Patna at the time of agreement.
12. Affidavit (By Notary) by firm not being debar from any authority of any tender.
13. Delay in supply may attract punitive deduction @0.5% per week and the maximum deduction is 5% of the contract price. On further delays, purchase order may be cancelled.
14. Quality of Indelible Ink/Marker Pen may be verified from any CSIR Institutions In India.

- (2) Sample of quoted items must be submitted with rate otherwise company will be disqualified.




