Dear Sir,

1. In first Lot of delivery, a 200 Nos. of Control Units and 600 Nos. of Ballot Unit will be dispatched from ECIL Hyderabad to SEC-Bihar Patna on 18<sup>th</sup> May 2026. For Dispatch of EVM, the ECI Protocol (copy attached as Annexure-1) will be followed. As per the protocol, kindly arrange security cover for transportation of EVMs from ECIL, Hyderabad to designated warehouse at Patna/ earmarked district.
2. Training will be conducted by ECIL technical team to Master Trainers of SEC-Bihar as per the scheduled plan. i.e from 25.05.2026 to 27.05.2026 at SEC-Bihar HQ, Patna.
3. The case regarding providing a Printer along with Totalizer will be taken up with ECIL Management; once the decision is being made the same will be conveyed to SEC-Bihar.
4. The User Acceptance Test (UAT) will be carried out, by ECIL Engineers and officials of SEC-Bihar/nominated people by SEC jointly at the venue decided by SEC-Bihar, immediately upon receipt of EVM at the destination or designated location. The UAT of EVM will have following steps:
  - a. Consignment Verification.
  - b. Visual Inspection of EVMs.
  - c. Check for Mechanical and Electrical Functioning.
  - d. Functional Testing of EVM and sample polling on EVM.
  - e. Repacking of EVMs for storage.

Upon Completion of UAT of consignment of EVM, an acceptance certificate will be issued by Customer i.e. SEC-Bihar as per the format attached at Annexure-2.

Subject: Standard Operating Procedure (SoP) for Movement of EVMs & VVPATs through the States/UTs that are undergoing elections - reg.

Madam/Sir,

I am directed to say that EVM/VVPAT inventory management involves movements like despatch of new supply from the manufacturers to various States/UTs, return of field rejects to the manufacturers for repairs, allocation of repaired units from the manufacturers to various States/UTs, need-based inter-State movement etc., from time to time, as ordered by the Commission. The factory sites of the manufacturer PSUs viz. Bharat Electronics Limited and Electronics Corporation of India Limited are located in different States like Karnataka (Bengaluru), Telangana (Hyderabad), Haryana (Panchkula), Andhra Pradesh (Tirupati) etc.

2. In this regard, it is stated that as per existing SoP/guidelines on movement involves:

- (a) Adequate foolproof armed security arrangements are made for the transportation of the machines.
- (b) Every vehicle carrying EVMs and VVPATs are fitted with GPS.
- (c) The movement of each of the vehicle carrying EVMs and VVPATs are closely monitored on daily basis, until it reaches the destination, by the Chief Electoral Officers/District Election Officers of the concerned State through which the vehicle carrying EVMs and VVPATs are to pass.
- (d) One Official, not below the rank of Tehsildar (or equivalent as known), with each vehicle is also appointed by the CEO/DEO and their cell numbers are given to concerned officers of States through which vehicle passes, who shall be in contact with the official on monitoring of the transportation of EVMs and VVPATs.

(e) A signage is labeled on the wind-screen of the vehicle carrying EVMs and VVPATs "Election Materials-Urgent" for smooth passage of the vehicle with clear mention of originating and destination places.

(f) Recognised National and State Political Parties are invited to remain present at the time of opening and closing of warehouses in the States.

3. Generally, movement of EVMs and VVPATs from or to or within poll bound State(s)/District(s) especially during the period commencing from Commissioning of EVMs/VVPATs to Counting of Votes shall be avoided, as there may be a possibility of miscommunication/disinformation resulting into avoidable aspersions. However, various essential movements of EVMs and VVPATs originating from or terminating at the poll bound State/district having the manufacturing premises/companies cannot be avoided for several weeks.

4. For this purpose, the manufacturers (BEL/ECIL) and the sender/receiver CEOs shall provide tentative full movement plan of containerised vehicles carrying EVMs and VVPATs to be passed through any enroute State/district in advance to the Chief Electoral Officer by email, letter and telephonically. The Chief Electoral Officer of poll-bound State/UT shall intimate the National & State Recognised Political Parties, in writing, about all such movements of EVMs and VVPATs that is planned through the State/UT and destined to go to or come from other States/UTs.

5. Responsibility to provide armed security, track GPS movement of vehicles and to inform enroute/destination States/UTs/PSUs shall be as follows:
