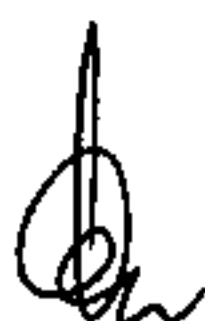
**Notification**

In exercise of the powers conferred under Section 64 of the Bihar Panchayat Raj Act, 2006 (Act 6 of 2006), the Governor of Bihar hereby issues the following order for the purpose of the declaration of Zila Parishad territorial constituencies:-

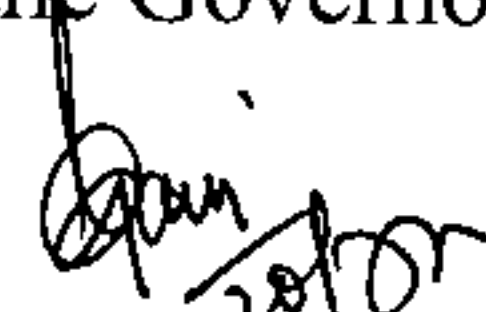
**Order**

1. Under the general or special orders, directions and instructions of the State Election Commissioner, and under its direction and supervision, the District Magistrate shall declare Zila Parishad territorial constituencies for the villages situated in each district.
2. The constitution/delimitation of Zila Parishad territorial constituencies shall be carried out on the basis of the census data published in the year 2011.
3. The district shall be treated as the unit for the declaration of Zila Parishad territorial constituencies.
4. The constitution/delimitation of all Zila Parishad territorial constituencies shall be carried out afresh according to revenue villages.
5. The constitution/delimitation of the territorial constituencies of the Zila Parishad shall be carried out in such a manner that:-
  - (a) all territorial constituencies of the Zila Parishad fall within the area of the concerned Zila Parishad;
  - (b) each territorial constituency of the Zila Parishad falls within the specified Panchayat Samiti area;
  - (c) in the constitution of the territorial constituencies of the Zila Parishad, the territorial constituency of a Panchayat Samiti is not divided under any circumstances.
6. The determination of a Zila Parishad territorial constituency shall commence from the north-west of the district and end in the south-east.



7. The continuous monitoring of the work of constitution/delimitation of Zila Parishad territorial constituencies being carried out at the district level shall be done by the concerned Divisional Commissioner, and compliance with the guidelines issued by the State Government and the State Election Commission shall be ensured.
8. The draft determination of the Zila Parishad territorial constituency shall be published in Form-7 by affixing it on the notice board of the concerned block office and the office of the District Magistrate, and it shall also be publicised through various means of communication.
9. After due consideration of the suggestions/objections received within 15 days from the date of publication, the District Magistrate shall determine the Zila Parishad territorial constituency.
10. The declaration of the determined Zila Parishad territorial constituency shall be made by the District Magistrate in Form-8 and published in the District Gazette.

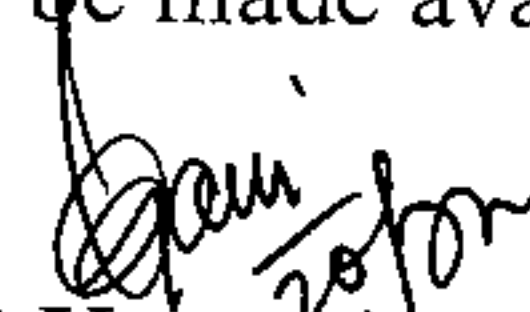

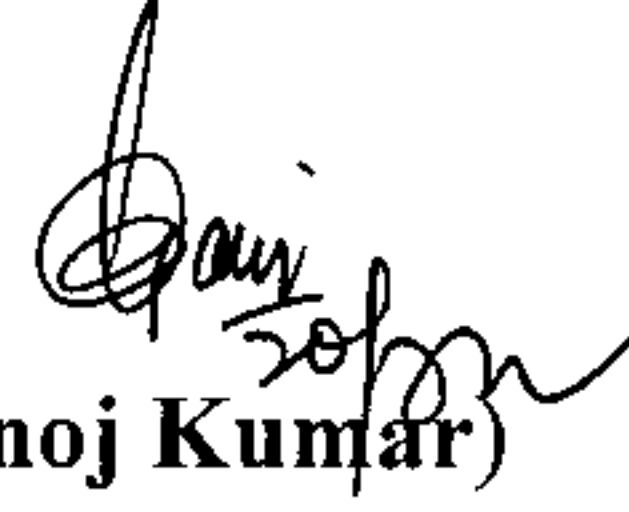
